Assignment Agreement

This Assignment Agreement ("Assignment") is entered into this ²¹~~20~~ day of July, 2008 by and between California Fruit and Tomato Kitchens, LLC, a California limited liability company (hereinafter "Cal Fruit"), and Gangi Bros.
