TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made as of April 1, 2008 by Great-West Life & Annuity Insurance Company (the "Assignor") and Connecticut General Life Insurance Company, a Connecticut domiciled insurance company with a principal place of business at Two Liberty Place, 1601 Chestnut Street, Philadelphia, Pennsylvania 19192 ("Buyer").

WITNESSETH:

WHEREAS, the Assignor owns the trademarks and the registrations and applications therefor as listed on Schedule A (collectively, the "Trademarks");

WHEREAS, pursuant to that certain Asset and Stock Purchase Agreement by and among the Assignor, First Great-West Life & Annuity Insurance Company, The Canada Life Assurance Company and Buyer dated as of November 26, 2007, (the "Purchase Agreement"), Assignor agreed to sell, assign and transfer to Buyer all of its right, title and interest to the Trademarks.

NOW, THEREFORE, in consideration of the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The Assignor does hereby confirm the sale, assignment and transfer to Buyer of all of its right, title and interest to the Trademarks pursuant to the Bill of Sale and General Assignment entered into as of April 1, 2008 in connection with the Purchase Agreement.
2. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO THE PRINCIPLES OF CONFLICTS OF LAW THEREOF.
3. This Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts together shall constitute one and the same instrument.


