TRADEMARK ASSIGNMENT

This Trademark Assignment is made and entered into as of July 29, 2008 (this "Assignment"), by Newsday, Inc., a New York corporation ("Newsday"), in favor of Newsday LLC, a Delaware limited liability company ("Newco Sub").

Pursuant to the Bill of Contribution (the "Bill of Contribution") dated as of July 29, 2008 made by Tribune Company, a Delaware corporation, Newsday, Distribution Systems of America, Inc., a New York corporation, Eagle New Media Investments, LLC, a Delaware limited liability company, Newport Media, Inc., a Delaware corporation, Star Community Publishing Group, LLC, a Delaware limited liability company, Tribune Manhattan Newspaper Holdings, Inc., a Delaware corporation, Tribune Media Net, Inc., a Delaware corporation, and Tribune New York Newspaper Holdings, LLC, a Delaware limited liability company, in favor of Newco Sub, Newsday has agreed to contribute all of its right, title and interest in and to the certain intellectual property, including, without limitation, the trademarks listed in the first column on Schedule 1 attached hereto (the "Trademarks") to Newco Sub.

The parties wish to execute this Assignment for purposes of transferring the Trademarks pursuant to the Bill of Contribution and filing this Assignment with the United States Patent and Trademark Office, and any other applicable trademark offices outside of the United States, as may be necessary to effectuate the assignment and transfer of the Trademarks to Newco Sub.

In consideration and in exchange for the sum of \$1.00 paid in hand to Newsday by Newco Sub, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Newsday hereby assigns and agrees as follows:


1. Newsday hereby assigns, transfers, conveys and delivers to Newco Sub all of its right, title and interest throughout the world in and to (a) each of the Trademarks, (b) the goodwill of the business symbolized by and associated with the Trademarks, (c) all applications and registrations for the Trademarks and (d) all rights to proceeds of the foregoing and all rights appurtenant to each of the Trademarks, including, without limitation, all claims that could be asserted by Newsday against third parties arising out of or relating to the use or ownership of the Trademarks.
2. Newsday hereby acknowledges and agrees that from and after the date hereof, Newco Sub shall be the exclusive owner of the Trademarks.
3. Newsday shall, at the reasonable request of Newco Sub or its successors, assigns and legal representatives, take such further action and execute such additional agreements and instruments as may be necessary to effect the assignment contemplated hereby and to perfect Newco Sub's title in and to the Trademarks. In addition, upon request, Newsday shall provide Newco Sub and its successors, assigns and legal representatives reasonable cooperation and assistance, in the prosecution or defense of any proceeding that may arise in connection with any of the rights assigned hereby. Such cooperation and assistance shall be at Newco Sub's sole cost and expense unless the proceeding results from a breach of any of Tribune Parties' representations or warranties in the Formation Agreement dated as of May 11, 2008 among CSC

Holdings, Inc., a Delaware corporation ("Cablevision"), NMG Holdings, Inc., a Delaware corporation and a wholly-owned subsidiary of Cablevision, Tribune Company, a Delaware corporation, Newsday, Newsday Holdings LLC, a Delaware limited liability company ("Newco"), and Newco Sub, and other Transaction Documents.
