**WHEREAS**, the First Assignee and Second Assignee, and successor in title General Electric Canada Corporation wish to release and restore all rights, title and interest in and to the Marks to the Assignor and to dissolve any and all liens and encumbrances respecting the Marks, as more particularly set forth on Schedule A attached hereto.

**NOW THEREFORE**, for good and valuable considerations, receipt of which is hereby acknowledged, the First Assignee and Second Assignee hereby release, discharge, quit claims and relinquish unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, the security interest in the trademarks, trademark applications and registrations as set forth on Schedule A hereto.


