| B | The Assignor has agreed to assign and has as of the effective date assigned to the Assignee its entire right, title and interest in and to the Registrations and Applications, on the terms and conditions contained in this Deed. |

It is agreed as follows.

1. Assignment

For good and valuable consideration, (the receipt and sufficiency of which is hereby acknowledged) the Assignor confirms that it has as of the effective date assigned to the Assignee and beneficial owner:

- (a) all its right, title and interest in and to the trade marks and the Registrations and Applications together with the goodwill of the business symbolized by the trade marks;
- (b) the right to lodge and prosecute further Applications to register the trade marks the subject of the Registrations and Applications in respect of any of the goods covered by the Registrations and Applications (any *Further Applications*);
- (c) the right to prosecute and obtain registration of any Further Applications;
- (d) the right to change the address for service for the Registrations and Applications and any further Applications; and
- (e) all its right to institute and maintain proceedings for trade mark infringement against any person who before, on or after the date of this Deed infringes rights given by the Registrations and Applications or by any registrations arising in relation to any Further Applications.

2. Forms

The Assignor must at the request of the Assignee:

3. Proceedings

The Assignor must, at the expense of the Assignee, render the Assignee such reasonable assistance as may be reasonably necessary in any proceedings involving the Registrations and Applications or any Further Applications (or any registrations arising from them) or any of the trade marks the subject of any of those Registrations or Applications.

4. Governing Law and Jurisdiction

This Deed is governed by the laws of Victoria, Australia. Each party submits to the jurisdiction of courts exercising jurisdiction there, and waives any right to claim that these courts are an inconvenient forum.

This Deed may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.


