Στην Αθήνα σήμερα την 20.3.2003, μεταξύ των κάτωθι συμβαλλομένων, αφενός της Ανώνυμης Εταιρείας με την επωνυμία «ΑΝΩΝΥΜΟΣ ΕΤΑΙΡΕΙΑ ΕΜΠΟΡΙΑΣ ΚΑΙ ΒΙΟΜΗΧΑΝΙΑΣ ΕΙΔΩΝ ΕΚ ΧΡΥΣΟΥ ΚΑΙ ΠΟΛΥΤΙΜΩΝ ΛΙΘΩΝ ΚΑΙ ΕΙΔΩΝ ΠΟΛΥΤΕΛΕΙΑΣ» και τον διακριτικό τίτλο «ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS», η οποία εδρεύει στην Αθήνα, επί της οδού Πανεπιστημίου αριθ. 10, [ΑΦΜ 094030932 ΔΟΥ ΦΑΕΕ Αθηνών], και εκπροσωπείται κατά την υπογραφή του παρόντος δια του Γεωργίου - Γκίκα Φαντόπουλου, κάτοικο Κηφισιάς Αττικής οδός Γρηγορίου Λαμπράκη αριθ. 21, [σύμφωνα με το από 18.3.2003 Πρακτικό του Διοικητικού Συμβουλίου της], και αφετέρου της Ανώνυμης Εταιρείας με την επωνυμία «ΚΟΣΜΗΜΑΤΟΠΟΙΙΑ ΖΟΛΩΤΑΣ ΑΝΩΝΥΜΟΣ ΕΤΑΙΡΕΙΑ» και τον διακριτικό τίτλο «ZOLOTAS JEWELERS S.A.», που εδρεύει στην Αθήνα επί της οδού Καλλιρρόης αριθ. 26, [ΑΦΜ 094248785 ΔΟΥ ΦΑΒΕ Αθηνών], και εκπροσωπείται νόμιμα κατά την υπογραφή του παρόντος, δια της Μαριάννας σφς. Νικολάου Παπαλέξη, το γένος Ρεμόν Λεκλαίρ, κάτοικο Αθηνών οδός Τριπόδων αριθ. 29, Πλάκα, [σύμφωνα με το υπ' αριθ. 150/7.3.2003 Πρακτικό του Διοικητικού Συμβουλίου της] συμφωνήθηκαν και έγιναν αμοιβαία αποδεκτά τα παρακάτω:

- I. Η αφενός συμβαλλόμενη Εταιρεία «ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS» έχει στην αποκλειστική κυριότητα, νομή και κατοχή της, με το δικαίωμα χρήσης, στην αλλοδαπή και σε διάφορες χώρες σήματα όπως αυτά περιγράφονται στην από 14 Φεβρουαρίου 2003 έκθεση της BUGNION SA και τα οποία έχουν κατατεθεί και έχουν γίνει δεκτά, καλύπτοντας διάφορες κλάσεις.
- II. Στην από 20.3.2003 Έκτακτη Γενική Συνέλευση των μετόχων της αφενός συμβαλλόμενης Εταιρείας «ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS», η οποία συγκλήθηκε νόμιμα, αποφασίσθηκε η μεταβίβαση (πώληση) των παραπάνω περιγραφέντων σημάτων στην αφετέρου συμβαλλόμενη Εταιρεία «ΚΟΣΜΗΜΑΤΟΠΟΙΙΑ ΖΟΛΩΤΑΣ ΑΝΩΝΥΜΟΣ ΕΤΑΙΡΕΙΑ», αντί του ποσού των εκατόν πενήντα χιλιάδων (150.000,00) ευρώ.
- III. Ήδη και δια του παρόντος, τα παραπάνω σήματα, όπως περιγράφονται στην από 14 Φεβρουαρίου 2003 έκθεση της BUGNION SA, η αφενός συμβαλλόμενη Εταιρεία

«ZOLOTAS – LA CHRYSOTHEQUE ZOLOTAS», με όλα τα δικαιώματά της σε αυτά προσωπικά και πραγματικά, και τις συναφείς αγωγές της, πωλεί σήμερα, εκχωρεί παραχωρεί, μεταβιβάζει και παραδίδει, στην αφετέρου συμβαλλόμενη Εταιρεία «ΚΟΣΜΗΜΑΤΟΠΟΙΙΑ ΖΟΛΩΤΑΣ ΑΝΩΝΥΜΟΣ ΕΤΑΙΡΕΙΑ», κατά πλήρη και αποκλειστική κυριότητα, νομή και κατοχή, με το δικαίωμα της αποκλειστικής χρήσης και εκμετάλλευσής του, καθώς και κάθε δικαίωμά της, από αυτό.

IV. Ως τίμημα για την μεταβίβαση των παραπάνω σημάτων, ορίζεται με το παρόν το ποσό των εκατόν πενήντα χιλιάδων (150.000,00) Ευρώ, το οποίο οι συμβαλλόμενες Εταιρείες, θεωρούν αληθές, δίκαιο και εύλογο.

V. Το παραπάνω ποσό, (τίμημα μεταβίβασης), καταβάλλεται από την αφετέρου συμβαλλόμενη Εταιρεία με την επωνυμία «ΚΟΣΜΗΜΑΤΟΠΟΙΙΑ ΖΟΛΩΤΑΣ ΑΝΩΝΥΜΟΣ ΕΤΑΙΡΕΙΑ», στην αφενός συμβαλλόμενη Εταιρεία «ZOLOTAS – LA CHRYSOTHEQUE ZOLOTAS», δια της ανάληψης, με σχετική σύμβαση, που θα υπογραφεί με την «ΤΡΑΠΕΖΑ ΠΕΙΡΑΙΩΣ Α.Ε.», της υποχρέωσης εκ μέρους της αφετέρου συμβαλλόμενης Εταιρείας, και της αντίστοιχης απαλλαγής της αφενός συμβαλλόμενης Εταιρείας, και των εγγυητών, έναντι της Τράπεζας Πειραιώς, ισόποσης οφειλής της αφενός συμβαλλόμενης Εταιρείας, απορρέουσας από πιστωτικές συμβάσεις, μεταξύ αυτής και της Τράπεζας Πειραιώς.

VI. ## TRADE MARK TRANSFER AGREEMENT

In Athens, this 20.3.2003, between the following contracting parties, on the one hand the Societe Anonyme under company name "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS", with registered offices in Athens, at no. 10 of Panepistimiou street, [Taxpayer's Record Number 094030932 REVENUE OFFICE Athens ΦΑΒΕ], being represented for the execution of the present agreement by Georgios – Gikas Fantopoulos, resident of Kifissia, Attica, at no.21 of Gregoriou Lambraki street [in virtue of its Board of Directors Minutes dated 18.3.2003], and on the other hand the Societe Anonyme under the name "ZOLOTAS JEWELERS S.A.", having its registered office in Athens at no. 26 of Kallirois street [Taxpayer's Record Number 094248785 REVENUE OFFICE Athens ΦΑΒΕ], being represented for the execution of the present agreement, by Marianna, spouse of Nikolaos Papalexis, daughter of Raymond Le Clère, resident of Athens, at no. 29 of Tripodon street, Plaka [according the under no 150/7.3.2003 Minutes of its Board of Directors] the following were mutually agreed upon :

- I. The first company of the contracting parties "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS" has the full proprietorship, possession and occupancy, and right of usage, abroad, in various countries, trade marks such as those described in the Report of BUGNION S.A. dated 14 of February 2003, which have been registered and were admitted, covering various classes.
- II. In the Extraordinary General Assembly of the Shareholders of the first company of the contracting parties "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS", dully summoned on 20.3.2003, the transfer (sale) of the aforementioned trade marks to the second company of the contracting parties "ZOLOTAS JEWELERS S.A." was concluded for the amount of EURO one hundred fifty thousand (150.000,00).
- III. By the present, "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS" legally represented with all its rights appertaining to the above mentioned trademarks, as they are described personal and real, and with its relative actions, today sells, assigns, transfers and gives, to the second company of the contracting parties "ZOLOTAS JEWELERS S.A.", the full proprietorship, possession and occupancy, and right of exclusive usage and exploitation, as well as all rights appertaining to the same.
- IV. As purchase price for the transfer of the aforementioned trademarks, the amount of EURO one hundred fifty thousand (150.000, 00) is hereby fixed, which the Contracting Companies consider true, fair and reasonable.

- V. The said amount, (transfer purchase price), is paid by the second company of the contracting parties, under company name "ZOLOTAS JEWELERS S.A.", to the first company of the contracting parties, "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS", by the undertaking, in virtue of relative agreement, entered with "PIRAEUS BANK S.A.", of the liability on behalf of the first company of the contracting parties, and of the respective discharge of the second company of the contracting parties as well as the guarantors, towards Piraeus Bank, of debt equal in amount of the first company of the contracting parties, arising from the credit agreements, between the same and Piraeus Bank.
- VI. The second company of the contracting parties "ZOLOTAS JEWELERS S.A.", states that it admits all the aforementioned and that it has received the full proprietorship, possession and occupancy and exclusive usage and exploitation of the said trade marks, and paid the amount of EURO one hundred fifty thousand (150.000,00), in the manner described above.
- VII. The contracting parties, as these appear and represented herein, state that they waive of all their rights to attack and to terminate the present agreement for any reason and cause.

Finally, they stipulate that the present transfer shall be effective as of the forwarding to BUGNION SA offices, of the present agreement, the General Assemblies decisions and letter with the order to take all the necessary steps for the transfer of the trademarks to the second company of the contracting parties "ZOLOTAS JEWELERS S.A.", and that the cost of this transfer is at the expense of the first company of the contracting parties "ZOLOTAS - LA CHRYSOTHEQUE ZOLOTAS".

The present agreement after reading and acknowledgment of its contents by the parties, was executed in four (4) identical copies, and each of the contracting parties received one, the third shall be submitted to relevant Revenue Office, and the fourth shall be submitted to competent service abroad for its registration.
