**TRADEMARK ASSIGNMENT**

This assignment made this 29th day of August, 2008, by and among Indybake Products, L.L.C., an Indiana limited liability company ("Indybake Products"), Indybake Properties, L.L.C., an Indiana limited liability company ("Indybake Properties"), Brownie Products Company, a Michigan corporation ("Brownie Products"), Brownie Property, L.L.C., an Illinois limited liability company ("Brownie Property," and, together with Indybake Products, Indybake Properties and Brownie Products, each an "Assignor" and collectively the "Assignors"), and KELLOGG NORTH AMERICA COMPANY, a Delaware corporation having its principal place of business at One Kellogg Square, Battle Creek, Michigan 49016 (hereinafter "Assignee").

Assignors agree that at any time and from time to time after the date hereof, at the reasonable request of Assignee and without further consideration, Assignors shall execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey and assign to Assignee, and to confirm Assignee's right, title and interest in and to the Marks and to assist Assignee in exercising all rights with respect thereto.

Nothing in this assignment, express or implied, is intended or shall be construed to confer upon, or give to, any Person, other than the parties to this assignment, any rights, remedies, obligations or liabilities.

This assignment shall bind and inure to Assignee and Assignors and their respective successors and assigns.

This assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same.
