
Assignment Agreement

This Assignment Agreement ("Assignment") is entered into this 31 day of July, 2008 by and between California Fruit and Tomato Kitchens, LLC, a California limited liability company (hereinafter "Cal Fruit"), and Sun Garden Packing Co., a California corporation (hereinafter "Sun Garden"). Cal Fruit and Sun Garden agree as follows:

1. Assignment. For valuable consideration, Sun Garden hereby grants, transfers and assigns to Cal Fruit all of Sun Garden's right, title and interest in and to the following trademarks: PARADISO, United States Trademark Registration No. 2,129,729 and KITCHEN KUT, United States Trademark Registration No. 2,011,827.

2. Miscellaneous. This Agreement shall (i) be binding on the successors, assigns and licensees of Cal Fruit and Sun Garden, (ii) inure to the benefit of the successors and assigns of Cal Fruit and Sun Garden, and (iii) be governed by and construed in accordance with the laws of the State of California.
