**THIS TRADEMARK RELEASE** is made as of August 29, 2008, by **UNION BANK OF CALIFORNIA, N.A.**, as Collateral Agent (in such capacity, "**Grantee**").

W I T N E S S E T H:

**WHEREAS**, Grantee and Web Service Company, LLC, a California limited liability company ("**Grantor**"), are parties to that certain Security Agreement dated as of September 11, 2007 (the "**Security Agreement**"; capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

**WHEREAS**, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 20, 2007 at Reel 3625, Frame 0065; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Grantee, the Bank Lenders and the Noteholders.

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby terminates the Security Agreement and terminates, cancels and releases its security interest in all of Grantor's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action existing by reason of infringement thereof (the "**Trademark Collateral**").

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any right, title and interest Grantee may have in and to the Trademark Collateral.

3. This release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.
