ASSIGNMENT OF TRADEMARK

KNOW ALL MEN BY THESE PRESENTS, that House of Herbs, Inc., a business corporation duly organized and existing under the laws of the State of New Jersey ("Seller"), having its principal place of business at 38 Ann Street, Passaic, NJ 07055, in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby grant, bargain, sell, transfer, convey, assign and deliver to House of Herbs I LLC, a limited liability company duly organized and existing under the laws of the State of New Jersey ("Purchaser"), all rights, title and interest in and to the House of Herbs trademark (the "Mark"), together with the goodwill symbolized by the Mark.

TO HAVE AND TO HOLD THE SAME UNTO PURCHASER AND ITS SUCCESSORS AND ASSIGNS FOREVER.

Seller's application to register the Mark was filed with the United States Patent and Trademark Office ("USPTO") on December 21, 1962 under serial number 72159587. The application to register the Mark was granted to Seller by the USPTO on May 12, 1964 under registration number 0769655. The registration was renewed on May 12, 1984 and December 30, 2003.

Seller hereby covenants to and with Purchaser that Seller (1) has good and marketable title to the Mark, subject to no liens, claims, encumbrances or restrictions of any kind, (2) has the right, power and authority to, and (3) hereby does, sell, transfer, assign and convey the Mark free and clear of all liens, claims, encumbrances and restrictions. Seller hereby covenants that it will warrant and defend the same against all lawful claims whatsoever.
