**MEMORANDUM OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

Nothing contained in this Memorandum of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Agreements or otherwise.


