**RELEASE OF LIEN ON TRADEMARKS**

This Agreement is intended to operate as a release of all liens and security interests conveyed by Assignee to Secured Party in the Released Trademarks pursuant to the Security Documents and to reassign to the Assignee all of Secured Party's right, title, and interest in and to the Released Trademarks.
