TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Assignment Agreement") is made and effective as of ____, 2008; by and between, Ageia Technologies, Inc., a Delaware corporation ("Seller"), and NVIDIA Corporation, a Delaware corporation ("Purchaser").

2. Seller hereby assigns to Purchaser all causes of action, claims and rights to damages or profits, due or accrued, arising out of past infringement of the Marks, or injury to the goodwill associated with the Marks, as well as the rights to sue for and recover the Marks in Purchaser's own name.

3. Seller represents and warrants that it will cooperate in any actions necessary for Purchaser to prosecute, renew or register its rights, title and interests in and to the Marks and Applications, including United States and foreign registrations, and to cooperate in any actions brought to enforce the rights accompanying this Assignment against third parties.


