TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of September 4, 2008, and made by U.S. Bank National Association, a nationally chartered banking association, as Trustee under the Indenture dated as of January 26, 2006 (the "Indenture"), by and among Holley Performance Products Inc. (the "Company"), certain of the Company's subsidiaries, and U.S. Bank National Association as Trustee (as defined therein).

WHEREAS, pursuant to the Indenture, a security interest was granted by the Company to the Trustee in certain collateral, including the Trademarks (as defined below);

WHEREAS, security interests in the Trademarks were recorded in the Trademark Division of the United States Patent and Trademark Office on February 1, 2006 at Reel/Frame No. 3238/0532;

WHEREAS, on March 18, 2008, the United States Bankruptcy Court for the District of Delaware confirmed the Debtors' Modified Joint Prepackaged Plan of Reorganization Under Chapter 11 of the Bankruptcy Code ("Plan"); and

WHEREAS, the Plan releases all liens held by the Trustee pursuant to section 4.6 of the Plan.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Trustee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Company's right, title, and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. The Trustee hereby terminates, releases, and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title, and interest of the Trustee in the Trademarks.


