Robert Mehrabian and Melanie S. Cibik certify that:

1. They are the duly elected and acting Chairman and Chief Executive Officer, and Vice President and Assistant Secretary, respectively, of Storm Products Co., a California corporation.
2. The Articles of Incorporation of the corporation shall be amended and restated to read in full as follows:

Name

One: The name of the corporation is Teledyne Storm Products, Inc.

Purpose

Two: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code. This corporation elects to be governed by all of the provisions of the General Corporation Law of 1977 not otherwise applicable to it under Chapter 23 thereof.

Authorized Shares

Three: The total number of shares which the corporation is authorized to issue is 60,000 shares of capital stock all of which shall be designated "Common Stock".

Director Liability

Four: The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

Indemnification of Agents

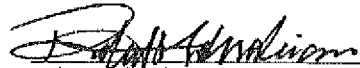
Five: The corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the applicable limits set forth in

Section 204 of the California Corporations Code with respect to actions for breach of duty to the corporation and its shareholders.

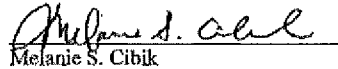
3. The foregoing Amended and Restated Articles of Incorporation have been duly approved by the Board of Directors of the Corporation.

4. The foregoing Amended and Restated Articles of Incorporation have been duly approved by the required vote of the shareholders of this Corporation in accordance with Sections 902 and 903 of the California General Corporation Law. The Corporation has only one class of shares and the total number of outstanding shares entitled to vote with respect to the foregoing Amended and Restated Articles of Incorporation is 60,000 shares. The number of shares voting in favor of the foregoing Amended and Restated Articles of Incorporation exceeded the vote required, such percentage vote required for the approval of the outstanding shares being more than fifty percent.

The undersigned have executed these Amended and Restated Articles of Incorporation on December 31, 2007.



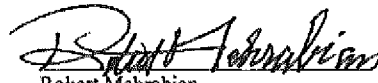

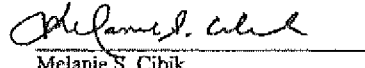
