WHEREAS, Algor has obtained the trademark registrations for certain of the Trademarks as are described in Exhibit A (the "Registrations"); and


WHEREAS, Inecom desires to purchase from Algor, and Algor has agreed to sell, all right, title and interest in and to the Trademarks and the Registrations;



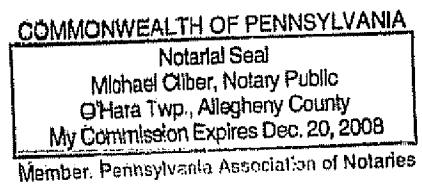
