**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 28, 2008, by HELLER FINANCIAL, INC., as agent for certain lenders (in such capacity, "Agent").

WITNESSETH:

WHEREAS, Agent and QUANTUM COMPOSITES, INC., an Ohio corporation ("Company"), are parties to a certain Trademark Security Agreement dated as of May 28, 1999 (the "Security Agreement"), pursuant to which Company granted a security interest to Agent in, among other things, certain trademarks, trademark applications and trademark licenses of Company (and intellectual property relating to same) as security for certain obligations owing by Company to Agent and the lenders for which it acts as Agent, including, without limitation, the trademarks, trademark applications and trademark licenses (and intellectual property relating to same) set forth on Exhibit A hereto; and

WHEREAS, Company has requested that Agent release its security interest in the Trademark Collateral (as defined in the Security Agreement), including the trademarks, trademark applications and trademark licenses described on Exhibit A hereto, and reassign the same to Company;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interests in all of Company's right, title and interest in and to the Trademark Collateral, including, without limitation, the trademarks, trademark applications and trademark licenses described on Exhibit A hereto.
2. Agent hereby reassigns, grants and conveys to Company, without any representation, recourse, warranty or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.
