TRADEMARK SECURITY INTEREST AGREEMENT

Dated: July 22, 2008

WHEREAS, ENEFCO INTERNATIONAL, INC., a corporation formed under the laws of Delaware, with a mailing address of 1130 Minot Avenue, P.O. Box 1120, Auburn, Maine 04211-1120 ("Borrower"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrower is obligated to RBS Citizens, National Association ("Lender") pursuant to (i) a certain Loan Agreement, dated as of the date hereof, among Lender, Borrower and the other parties thereto, and (ii) a certain Security Agreement, dated as of the date hereof, made by Borrower in favor of Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Borrower is granting to Lender for its benefit a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Borrower does hereby grant unto Lender for its benefit a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which security interest shall secure all the Obligations or Secured Obligations as defined in the Agreements and in accordance with the terms and provisions thereof. Borrower expressly acknowledges and affirms that the rights and remedies of Lender with respect to the security interest granted hereby are more fully set forth in the Agreements.
