TRADEMARK ASSIGNMENT

WHEREAS, Diamintangibles International, LTD, a Bahamian company with a place of business at Valdy Administration Inc., Suite 303, One Bay Street, British Colonial Center of Commerce, P.O. Box 11, 7115 Nassau, Bahamas (hereinafter "ASSIGNOR"), is the owner of all right, title and interest in and to the trademark FACETS OF FIRE (hereinafter the "MARK") in the United States, including the common law rights pertaining thereto and the U.S. Trademark Registrations thereof identified in Schedule A attached hereto and incorporated herein by reference, and is the owner of the goodwill of the business symbolized by the MARK and connected with the use thereof; and

WHEREAS, Leo Schachter Diamonds Ltd., an Israeli company with a place of business at 54 Bezael Street, Ramat Gan 52521 Israel (hereinafter "ASSIGNEE"), is desirous of acquiring an undivided 50% ownership interest in the MARK;

NOW, THEREFORE, in consideration of the foregoing premises and the mutual promises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. ASSIGNOR hereby does assign, transfer and convey, effective as of the date hereof, to ASSIGNEE, its successors, legal representatives and assigns, an undivided 50% ownership interest in the MARK in the United States, together with the goodwill of that portion of ASSIGNOR'S business symbolized thereby, including without limitation, the right to petition, sue or otherwise seek and recover damages, profits and any other remedy (monetary, injunctive, declaratory or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to the

MARK, or any license, agreement, contract or other matter relating thereto in the United States.

2. As joint owners of the MARK, ASSIGNOR and ASSIGNEE agree to work together to preserve and protect the MARK and the goodwill of the business symbolized thereby and take such action as may be necessary from time to time to protect the MARK from infringement. In no event shall either party take any such action without the prior written consent of the other.

3. Neither party shall assign or license any rights in the MARK in the United States without the prior written consent of the other which shall not be unreasonably withheld.

4. ASSIGNOR agrees that it will execute and deliver, or cause to be executed and delivered, to ASSIGNEE or ASSIGNEE's legal representatives, any other or additional assignments, powers and other appropriate documentation, and take all additional actions, necessary to effectuate, validate and record this Assignment with the United States Patent and Trademark Office within a reasonable time of execution hereof.

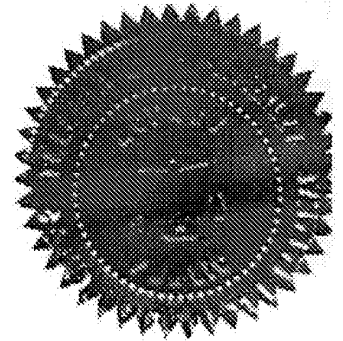
