TRADEMARK ASSIGNMENT

WHEREAS, Marisa Christina Apparel, Inc., a corporation duly organized and existing under the laws of the State of Delaware and having offices at 1410 Broadway, 20th FL., New York, New York 10018, United States of America (and successor by name change to Marisa Christina, Inc.) ("Assignor") and B2X, a corporation duly organized and existing under the laws of the State of Delaware and having its principal office at 10 Exchange Place, 25<sup>th</sup> Floor, Jersey City, NJ 07302, United States of America ("Assignee") entered into a Trademark Assignment Agreement dated as of November 2, 2007 (the "Assignment Agreement");

WHEREAS, this Trademark Assignment is delivered pursuant to, and is subject to the terms and conditions of the Assignment Agreement;

WHEREAS, pursuant to the Assignment Agreement, Assignor shall retain all right, title and interest in and to the Marks in Japan (the "Japanese Rights"); and

NOW THEREFORE, for good and valuable consideration described in the Assignment Agreement, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree:

Except for the Japanese Rights, which are retained by Assignor, effective as of November 2, 2007, Assignor, did sell, assign, and transfer to Assignee, absolutely and forever, the entire right, title, and interest, whether statutory or at common law, in and to the trademark MARISA CHRISTINA and KNITWORKS BY MARISA CHRISTINA (the "Marks") together with the goodwill of the business symbolized by such Marks, and all corresponding registrations and applications, including those applications and registration included in Schedule A, as well as all causes of action for any and all previously occurring infringements of the rights assigned and the right to receive and retain the proceeds relating to those infringements.

Assignor agrees to execute any further papers and to do such other acts as may be necessary and proper to vest full title in and to the Marks and other corresponding rights in the Assignee.
