**ASSIGNMENT OF INTELLECTUAL PROPERTY

NOW, THEREFORE, be it known that, for the valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all right, title, and interest, throughout the world, in, to and under all intellectual property associated with the outdoor products operation of Jenn Feng and held in the name of McCulloch Corporation, including, but not limited to inventions, whether patented/registered, patent/registration applied for or not patented/registered, designs whether patented/registered, patent/registration applied for or not patented/registered, trademarks/service marks, whether registered, registration applied for or not registered, copyrights whether registered, registration applied for or not registered, trade secrets and trade dress, and all improvements, modifications, variations, applications and all divisions, continuations reissues, reexaminations and extensions thereof, and all right to sue for any past infringement have been and are hereby sold, assigned, transferred, and delivered unto Husqvarna as assignee, its successors and assigns; and it is covenanted and agreed by the undersigned, and for executors, administrators, and legal representatives of the undersigned, that at Husqvarna's request any and all applications, affidavits, assignments, and other instruments will be made, executed, and delivered as may be necessary, or desirable to secure for or vest in Husqvarna as assignee, its successors or assigns any right transferred to Husqvarna worldwide, and that appropriately empowered officials of all countries, including but not limited to the United States Commissioner of Patents and Trademarks, are hereby requested and


authorized to accept this assignment of all intellectual property associated with the outdoor products operation of Jenn Feng in order to register and/or record Husqvarna as owner of the entire right, title, and interest in, to, and under the same, and to issue any and all patents, registrations, certificates and the like granted on any applications to Husqvarna as owner of the entire right, title, and interest in, to, and under the same.
