ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF

MARK HARRIS PUBLISHING ASSOCIATES, INC.

1. The name of the corporation is MARK HARRIS PUBLISHING ASSOCIATES, INC. ("Corporation").

2. Article I of the Corporation's Article of Incorporation is amended to read as follows:

"ARTICLE I

The name of the Corporation shall be Polacek Publishing Corporation."


3. The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

4. The amendment was adopted the 8<sup>th</sup> day of January, 2007.

5. The amendment was approved by the shareholders. There is one voting group eligible to vote on the amendment. The single voting group consisting of 100,000 outstanding shares of common stock is entitled to 100,000 votes. There were 100,000 votes indisputably present at the meeting. The voting group cast 100,000 votes for and 0 votes against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.
