ARTICLE I Amendment

<u>Section 1</u>. The date of incorporation of the Corporation is August 13, 2008.

Section 2. The name of the corporation following this restatement of the Articles of Incorporation is FURminator, Inc.

Section 3. The exact text of the Restated Articles of Incorporation is attached hereto as Exhibit A.

AMENDED AND RESTATED ARTICLES OF INCORPORATION

ARTICLE I Name


The name of the Corporation is FURminator, Inc.

ARTICLE II Registered Office and Registered Agent

The street address of the Corporation's registered office in Indiana and the name of its registered agent at that office are: Julianne S. Lis-Milam, Hammond, Kennedy, Whitney & Company, Inc. 8888 Keystone Crossing, Suite 600, Indianapolis, Indiana 46240.

ARTICLE III Shares

- A. <u>Number of Authorized Shares</u>. The Corporation is authorized to issue 100,000,000 shares of capital stock, no par value (the "Common Shares"), consisting of 95,000,000 voting common shares and 5,000,000 nonvoting common shares.
- B. <u>Voting Rights</u>. A holder of voting common shares shall be entitled to one vote per voting common share on each matter submitted to a vote of the shareholders of the Corporation. Except as otherwise required under the Indiana Business Corporation Law, a holder of nonvoting common shares shall not have the right to vote with respect to the holder's nonvoting common shares.
- C. <u>Distribution Rights</u>. With respect to any distribution by the Corporation to the its shareholders of any cash, securities or other property, there shall be distributed the same amount of cash, securities or other property with respect to each voting common share and each nonvoting common share, except that with respect to a distribution of Common Shares, voting common shares shall be distributed in respect of voting common shares and nonvoting common shares shall be distributed in respect of nonvoting common shares. If the Common Shares are divided into a greater number of Common Shares or combined into a lesser number of Common Shares, the voting common shares and the nonvoting common shares shall be divided or combined in the same proportion.
