TRADEMARK AGREEMENT

This Trademark Agreement ("Agreement") is entered into effective as of July August 15, 2008, by and between:

MedImmune, LLC, a Delaware, USA limited liability company with its registered office at Corporation Trust Center, 1209 Orange Street, Wilmington DE 198001 and a principal place of business at One MedImmune Way, Gaithersburg, MD 20878,

AstraZeneca AB, company number 556011-7482 a Swedish company with its registered office at 15185 Sodertalje, Sweden, and

Glaxo Group Limited, company number 305979, an English corporation with its registered office at Glaxo Wellcome House, Berkeley Avenue, Greenford, Middlesex, UB6 ONN, England.

Whereas, MedImmune, LLC ("MedI") owns trademark applications and/or registrations for the mark TACTEVO in a number of countries.

Whereas, AstraZeneca AB ("AZ") owns trademark applications and/or registrations for the mark CELAMIR in a number of countries.

Whereas, Glaxo Group Limited ("GSK") owns trademark applications and/or registrations for the mark TACTAVO, SALIMER and ZALIMER in a number of countries.


Now, therefore, in consideration of the promises and agreements set forth herein, and intending to be legally bound hereby, the parties agree:

1. AZ agrees to assign, and hereby assigns, to GSK any and all of its right, title and interest in and to the mark CELAMIR throughout the world and any and all trademark applications and registrations it owns for the mark, including without limitation those set forth on Schedule A.
2. GSK agrees to assign, and hereby assigns, to MedI any and all of its right title and interest in and to the mark TACTAVO throughout the world and any and all trademark applications and registrations it owns for the mark, including without limitation those set forth on Schedule B.
3. The assignments in clauses 1 and 2 of this Agreement include the assignment to the respective assignees of the right to take action and recover damages, an account of profits, and all other remedies in respect of any infringement of the assigned marks, whether or not such infringement or conduct took place before the date of this Agreement.

4. AZ and MedI agree to neither challenge the use or registration of the CELAMIR, SALIMER and ZALIMER marks by GSK, nor the legal validity of those marks.
5. GSK agrees to neither challenge the use or registration of the TACTEVO and TACTAVO marks by MedI, nor the legal validity of those marks.
6. AZ and MedI agree not to use or register the marks CELAMIR, ZALIMER and SALIMER.
7. GSK agree not to use or register the marks TACTAVO and TACTEVO.
8. The parties agree to cooperate in implementing the terms of this agreement as reasonably requested by the other party and each party shall bear its own costs in such cooperation. For example and without limitation, each party agrees to execute documents as reasonably requested by the other to evidence and record the assignment of a mark in a particular country. For the avoidance of doubt, any such documents will be prepared by and at the expense of the relevant assignee.
9. This Agreement shall be effective worldwide.
10. This Agreement shall be binding upon the parties, and their respective successors and assigns. This Agreement shall be binding upon affiliates of the parties, with "affiliate" defined as any entity that directly or indirectly controls, is controlled by or is under common control with such party.
11. This Agreement shall be governed by and construed in accordance with English law.
12. The Courts of England and Wales shall have exclusive jurisdiction to settle any claim, dispute or matter of difference which may arise out of or in connection with this Agreement.

In witness whereof, the parties have caused this Trademark Agreement to be executed by duly authorized representatives.


