hereinafter jointly referred to as the "Assignor"

- (3) **MEDLOCK MEDICAL LIMITED** a company incorporated in England under company number 4977601 whose registered office is at Tubiton House, Oldham, OL1 3HS ("Assignee")

**BACKGROUND**

- A The Assignor is the proprietor of the registered trade marks and the trade mark applications listed in schedule 1 of this agreement ("**Trade Marks**").
- B The Assignor has agreed to assign and transfer all legal and beneficial right title and interest in and to the Trade Marks and all goodwill that may have accrued to the Assignor by its use of the Trade Marks to the Assignee and the Assignee has agreed to accept such assignment, subject to and in accordance with the terms of this assignment.

**1. ASSIGNMENT**

1.1 For good and valid consideration as described in section 2 of the sale and purchase agreement by and between (1) SSL Products Limited (2) SSL International Plc and (3) the Assignee and dated 12 March 2004, now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby agrees to assign or procure the assignment to the Assignee of:

1.1.1 all legal and beneficial rights title to and interest in and to the Trade Marks including any common law rights and for the avoidance of doubt all goodwill attributable and associated with the Trade Marks; and

1.1.2 the right to bring proceedings against any third party in respect of infringement of the Trade Marks or for passing off or for otherwise

infringing the rights of the Assignor in the Trade Marks, including the right to claim damages or such other relief as may be available in respect thereof.

1.2 The Assignor shall at the request of the Assignee execute or procure the execution of formal trade mark assignments and/or other documents in such form as the Assignee shall reasonably require for the purposes of effecting the assignment of any of the Trade Marks agreed to be assigned pursuant to clause 1.1.1 and/or the recordal at any national registry of the Assignee as the registered proprietor of any or all of the Trade Marks.

## 2. GOVERNING LAW AND JURISDICTION






