RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Strategic Materials, Inc., a Delaware corporation ("Debtor"), with its principal place of business at 16365 Park Ten Place, Suite 200, Houston, Texas 77084, granted a security interest in, and lien upon, certain trademarks and related rights to LaSalle Business Credit, Inc. 
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Security Agreement is terminated; and
