INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement, dated as of December 15, 2006 (the "Assignment") is by and between Strata Group, Inc., a Virginia corporation ("Assignor"), and The Strata Group, Inc., a Delaware corporation ("Assignee").

WITNESSETH

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of December 15, 2006 (the "Agreement"), pursuant to which Assignor has agreed to sell, convey, assign and transfer to Assignee, and Assignee has agreed to accept and assume from Assignor, the Company IP (as such term is defined in the Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby irrevocably sell, assign, transfer, set over, and deliver, to Assignee, in perpetuity and throughout the world, the entire right, title, and interest in and to any and all Company IP purported to be transferred pursuant to the Agreement and including, without limitation, the right to sue for and recover damages for any past, present or future infringement of any rights related to such Intellectual Property and, moreover, it is intended by the parties to the Agreement that the Company IP and attendant rights shall be held and enjoyed by Assignee or its designee(s) as entirely as the same would have been held and enjoyed by the Assignor had this sale, assignment and transfer not been made.

2. For no additional consideration, Assignor does hereby further agree and promise to execute all instruments and render all such assistance as Assignee may reasonably request in order to make and prosecute any and all applications on the Company IP or to confirm in Assignee or its designee(s) legal title to the Company IP and all Intellectual Property pertinent to the Company IP.

3. Assignor hereby constitutes and appoints Assignee as Assignor's true and lawful attorney in fact, with full power of substitution in Assignor's name and stead, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest or perfect the aforesaid rights and causes of action more effectively in Assignee or to protect the same or to enforce any claim or right of any kind with respect thereto. Assignor hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

4. This Assignment shall be governed and construed in accordance with the laws of the State of New York, without regard to the applicable principles of conflict of laws.
