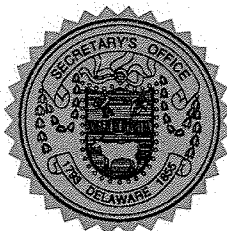

Integra LifeSciences Corporation, a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on December 13, 1993, effective as of January 1, 1994, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of common stock of Padgett Instruments, Inc., a Missouri corporation incorporated on September 6, 1990.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the Board on December 17th, 2003, determined to and did merge into itself said Padgett Instruments, Inc., on the conditions set forth in such resolutions:

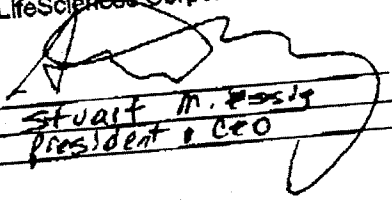
RESOLVED, that the Plan of Merger dated as of the date hereof merging Padgett Instruments, Inc. (the "Subsidiary") into Integra LifeSciences Corporation (the "Corporation") is hereby adopted and approved; pursuant to the terms and conditions of the Plan of Merger, the Subsidiary shall be merged with and into the Corporation and the Corporation shall be the surviving corporation and shall assume the Subsidiary's liabilities and obligations; and

FURTHER RESOLVED, that the merger shall be effective on December 31, 2003; and

FURTHER RESOLVED, that the officers of the Corporation, or any of them, be and hereby are authorized and directed to execute, on behalf of the Corporation, and deliver to the surviving Corporation, the Plan of Merger and to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge the Subsidiary into the Corporation and to assume the Subsidiary's liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State of Delaware and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect said merger.

IN WITNESS WHEREOF, the Corporation has caused this Certificate of Ownership and Merger to be signed by a duly authorized officer this 17 day of December, 2003.
