## TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor sells, assigns, transfers and conveys to Assignee the entire right, title and interest in and to the Trademarks in the United States and every jurisdiction throughout the world, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations of the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, any common law rights in the Trademarks, the right to enforce the Trademarks, the right to enjoin others from using the Trademarks, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner for Trademarks and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and applications for registration set forth on Exhibit 1 to Assignee as assignee of Assignor's entire right, title and interest therein.

The invalidity or unenforceability of one or more provisions of this Agreement shall not affect any other provision of this Agreement.

This Agreement is governed by the laws of the state of Tennessee without regard to conflict of laws principles, and any disputes concerning the terms or enforcement of this Agreement must be resolved in the federal or state courts located in Davidson County, Tennessee.

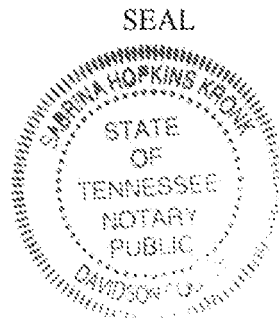
