


In view of the payment of \$10,000.00, and other legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor DOES HEREBY irrevocably assign and transfer to Assignee, any and all right, title and interest in and to the Trademark Rights subject to the terms of this Assignment and the Bill of Sale between the parties.


Assignor shall, without further consideration, execute any additional documents as may be reasonably requested by Assignee to prove and record this Assignment.
