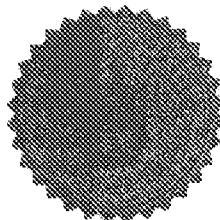

**FIRST:** The name of the corporation is Ranbaxy Pharmaceuticals Inc. (the "Corporation").


**SECOND:** Paragraph 1 of the Certificate of Incorporation of the Corporation is hereby deleted in its entirety and amended to read as follows:
