## Background

### 2. Further assistance

The Assignor must at the Assignee's expense execute any further documents that may be required to enable the Assignee to record this assignment on the relevant Trade Marks Register.

### 3. Counterparts

This Deed may be executed in any number of counterparts (including facsimile copies) and provided each of the parties have executed a counterpart, the counterparts shall together constitute a binding and enforceable agreement between the parties.




