RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST ("Release") is made and entered into as of this 27th day of June, 2008 by **AMSouth Bank**, a Banking Institution, and **Freedom Scientific Inc.**, a Delaware Corporation (collectively the "Parties") for the benefit of **Perks Unlimited, Inc.**

WHEREAS, Freedom Scientific Inc., as assignor, and AMSouth Bank, as assignee, inadvertently filed a security agreement ("Security Agreement") with the U.S. Patent and Trademark Office against U.S. Trademark Registration No. 1,786,961 for the PERKS mark owned by Perks Unlimited, Inc.;

WHEREAS, Freedom Scientific Inc. never had any right, title, or interest in and to U.S. Trademark Registration No. 1,786,961 for the PERKS mark.

WHEREAS, the U.S. Patent and Trademark Office recorded the Security Agreement on January 28, 2005 at Reel/Frame 3136/0175 against U.S. Trademark Registration No. 1,786,961 for the PERKS mark owned by Perks Unlimited, Inc. A true and correct copy of the Trademark Assignment Abstract of Title from the United States Patent and Trademark Office online database is attached as Exhibit A; and

WHEREAS, Perks Unlimited, Inc. requested that AMSouth Bank terminate and release any and all purported security interests, rights, titles, and interests it inadvertently filed under the Security Agreement against U.S. Trademark Registration No. 1,786,961 for the PERKS mark owned by Perks Unlimited, Inc.

NOW THEREFORE, in consideration of the above premises and the mutual covenants contained herein, AMSouth Bank and Freedom Scientific Inc. hereby **TERMINATE AND RELEASE** any and all purported security interests, rights, titles, and interests AMSouth Bank and Freedom Scientific Inc. allegedly have or had in U.S. Trademark Registration No. 1,786,961 for the PERKS mark owned by Perks Unlimited, Inc. AMSouth Bank and Freedom Scientific Inc. hereby consent to and authorize Perks Unlimited, Inc. to file this Release with the U.S. Patent and Trademark Office to evidence the termination of any and all purported security interests, rights, titles, and interests AMSouth Bank and Freedom Scientific Inc. allegedly have or had under the Security Agreement with respect to U.S. Trademark Registration No. 1,786,961 for the PERKS mark owned by Perks Unlimited, Inc.
