MKT10, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: The name of the Corporation is MKT10, INC.

SECOND: The original name of this company is tgssoft, inc. and the date of filing the original Certificate of Incorporation of this company with the Secretary of State of the State of Delaware (the "*Secretary*") was December 22, 2003 (the "*Original Certificate*"). The Original Certificate was amended on October 29, 2004 and was amended and restated by the Amended and Restated Certificate of Incorporation filed with the Secretary on February 24, 2005. The Amended and Restated Certificate of Incorporation was amended on April 26, 2005, August 31, 2005 and on February 13, 2006 and was amended and restated by the Second Amended and Restated Certificate of Incorporation filed with the Secretary on April 12, 2006.
