## TRADEMARK ASSIGNMENT

This ASSIGNMENT (the "*Assignment*"), effective as of September 16, 2008, by and between OBESITY RESEARCH INSTITUTE, LLC, a California Limited Liability Company, located at 17185 Via Barranca Del Zorro, Rancho Santa Fe, California, 92067 ("*Assignor*"), and ZYLOTRIM, LLC, a California Limited Liability Company, located at 17185 Via Barranca Del Zorro, Rancho Santa Fe, California, 92067 ("*Assignee*").

### RECITALS:

- A. Assignor is the record owner in the U.S. Patent and Trademark Office of the trademark identified by Registration Number 3,482,124, for the mark ZYLOTRIM, including all common law rights thereto (the "*Trademark*"), and the goodwill of the business symbolized thereby (together with the Trademark, the "*Assigned Property*").
- B. Assignor has effectively transferred to Assignee that portion of its existing and ongoing business to which the Assigned Property pertains.
- C. Assignor agrees to assign its entire right, title and interest in and to the Assigned Property to Assignee.
- D. Assignee agrees to acquire Assignor's entire right, title and interest in and to the Assigned Property.

### AGREEMENT:

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Trademark, free and clear of any liens, charges and encumbrances, including, without limitation, licenses and covenants by Assignor not to sue third persons, and Assignor hereby assigns to Assignee, its successors and assigns, its entire right, title and interest in and to the Assigned Property, and all rights and privileges pertaining to said Trademark in conformance with 15 U.S.C. §1060; 37 C.F.R. §3.16, together with the goodwill of the business symbolized by the mark, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Assigned Property, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.
2. The Trademark is subsisting and has not been adjudged invalid or unenforceable, in whole or in part.
3. For the above-named consideration, Assignor does hereby agree to, at the request of Assignee, execute any and all papers and documents and do all other and further lawful acts that Assignee may deem necessary or desirable to perfect and vest in the Assignee the entire right, title and interest in the intellectual property being assigned.

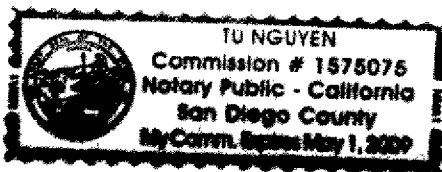
