TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made this 9/11 day of April, 2008, by BALLANTYNE OF OMAHA, INC., a Delaware corporation, having its principal place of business at 4350 McKinley Street, Omaha, Nebraska 68112 (hereinafter called "Assignor"), to FLAVOR-CRISP, INC., a Nebraska corporation, having its principal place of business at 1602 Clark Street, Fort Calhoun, Nebraska 68023 (hereafter called "Assignee").

WHEREAS, Assignor has used the Trademarks "Flavor-Crisp" and "Flavor-Pit" in connection with its food service business; and

WHEREAS, said "Flavor-Crisp" Trademark was granted federal registration originally on May 30, 1972, under Reg. No. 935-023, and also on August 6, 1968, under Reg. No. 854-276; and

WHEREAS, said "Flavor-Pit" Trademark was granted federal registration on December 20, 1988, under Reg. No. 1,517,126; and

WHEREAS, Assignor has not assigned its rights to the "Flavor-Crisp" Trademarks or "Flavor-Pit" Trademark, and has not encumbered such rights by the grant, license or other right heretofor given; and

WHEREAS, since their initial use in commerce and since the above registration dates, said Marks have been used continuously in commerce by Assignor, through and including the date hereof; and

WHEREAS Assignor and Assignee have entered into an Asset Purchase Agreement dated March 26, 2008, for the purchase and sale of certain assets including the Trademarks "Flavor-Crisp" and "Flavor-Pit" and the products and business associated therewith.


