
1. The date on which the Other Entity was first formed was July 11, 2005.

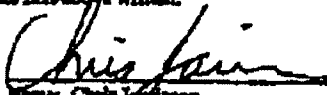
