RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE dated as of September 9, 2008, by and between JPMORGAN CHASE BANK, N.A., (i) as Administrative Agent and Collateral Agent for the Lenders, and (ii) successor-in-interest to Chemical Bank (in such capacities, collectively, the "Administrative Agent") and LIVE NATION WORLDWIDE, INC. (formerly known as SFX Entertainment, Inc., the "US Borrower"). All capitalized terms used herein that are defined in the Credit Agreement or Domestic Collateral Agreement referred to below and that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Credit Agreement or Domestic Collateral Agreement.

Reference is made to (a) the Amended and Restated Credit Agreement dated as of July 17, 2008 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Live Nation, Inc. (formerly known as CCE Spinco, Inc.) ("Parent"), the US Borrower, the Foreign Borrowers party thereto, the Lenders party thereto, the Administrative Agent, JPMorgan Chase Bank, N.A., Toronto Branch, as Canadian Agent, J.P. Morgan Europe Limited, as London Agent, and Bank of America, N.A., as Syndication Agent, (b) the Amended and Restated Guarantee and Collateral Agreement dated as of June 29, 2007 (as amended, supplemented or otherwise modified from time to time, the "Domestic Collateral Agreement"), among Parent, the US Borrower, Live Nation Motor Sports, Inc. (the "Subsidiary Grantor"), the other Subsidiaries of Parent identified therein and the Administrative Agent, and (c) that certain Assignment of Security Interest in U.S. Trademarks, dated as of March 10, 1995 (the "MSG Trademark Security Agreement"), entered into by MSG Holdings, L.P., a Delaware limited partnership ("MSG") and Chemical Bank, as Collateral Agent, as recorded in the United States Patent and Trademark Office, at Reels/Frames 1320/392 recorded April 7, 1995.

Pursuant to the Domestic Collateral Agreement, among other things, the Subsidiary Grantor pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in, among other things, all of the Subsidiary Grantor's right, title, and interest in and to the trademarks and trademark applications of the Subsidiary Grantor set forth on Annex I hereto (the "JPM Trademarks"), which security interest was recorded with the United States Patent and Trademark Office.

Pursuant to the MSG Trademark Security Agreement, MSG granted a security interest in all of its rights, title and interest in and to the trademarks of MSG set forth on Annex II hereto (the "Chemical Bank Trademarks"), and together with the JPM Trademarks, the "Trademarks"), which security interest was recorded with the United States Patent and Trademark Office on April 7, 1995 at Reels/Frames 1320.392.

In connection with the sale of the Subsidiary Grantor pursuant to Section 6.05(m) of the Credit Agreement, the US Borrower and the Subsidiary Grantor have informed the Administrative Agent of their desire to obtain the release of all rights, title and interest (including, without limitation, all security interests) of the Administrative Agent in and to the Trademarks granted under the Domestic Collateral Agreement and, as successor-in-interest to Chemical Bank, the Trademark Security Agreement.

Accordingly, for good and valuable consideration, receipt of which is acknowledged, the Administrative Agent hereby releases and terminates the Lien created by the Subsidiary Grantor under the Domestic Collateral Agreement and MSG under the Trademark Security Agreement, and all other rights, title and interest (including, without limitation, security interests) of the Administrative Agent (for itself and on behalf of the Secured Parties), in and to the Trademarks and all other Collateral derived therefrom. The Administrative Agent agrees to make appropriate Uniform Commercial Code termination statements filings, filings with the United States Patent and Trademark Office and other necessary filings to evidence the release and termination of such Liens and security interests covering the Trademarks, in each case at the expense of the US Borrower.

The US Borrower agrees, upon reasonable request of the Administrative Agent, at any time and from time to time, to execute and deliver all such further documents and take such action as may be reasonably necessary or appropriate in order to effectively confirm or carry out the provisions hereof.

This Release shall be construed in accordance with and governed by the law of the State of New York.

This Release may be executed by one or both of the parties to this Release on separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart hereof.
