**ASSIGNMENT**



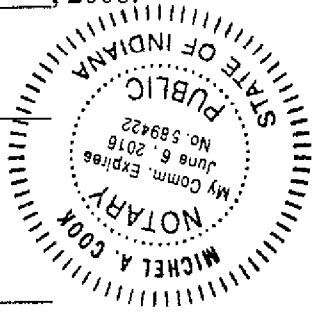
