**Sisco Textiles NV**, a company incorporated under the laws of the Netherlands Antilles, with its business address at Professor Kernkampweg 8a, PO Box 3360, Curacao, Netherlands Antilles ("**Assignee**"), on the other hand;

collectively to be referred to as "**the Parties**" or individually as "**a Party**";

### Whereas:

W&S assigned its rights and obligations under the SPA in accordance with Section 12.3 thereof to Sisco Textiles NV pursuant to an Assignment Agreement dated as of May 1, 2007, and
