## ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK is made the 15 day of August, 2008, by CounterStorm Inc. ("CounterStorm"), a Delaware corporation with principal place of business at 7400 Beaufont Springs Drive, Suite 403, Richmond, VA 23225.

WHEREAS, CounterStorm has used in commerce and is the owner of the trademark, CounterStorm (the "Mark"), U.S. Registration No. 3,160,519, for computer software in the field of network security for use by system administrators and security professionals to manage the security and integrity of data and information within computer networks, systems and applications; and

CounterStorm agrees to sign and deliver all further documents and perform all further acts reasonably necessary to effect, perfect, and/or evidence the transfer of the rights assigned to TCS in this Assignment of Trademark.


