ASSIGNMENT

This Assignment granted on this 11th day of September, 2008, by FAR EAST NATIONAL BANK ("Assignor") to DYNAMIC POWER ENTERPRISE CO., LTD. ("Assignee"), as follows:

WITNESSETH

WHEREAS, PULL'R HOLDINGS, LLC, a Delaware limited liability company (the "Grantor") executed a Patent and Trademark Security Agreement, dated as of November 7, 2006, in favor of Assignor, duly recorded on March 29, 2007, at Trademark Reel 003511, Frame 0014 in the United States Patent and Trademark Office (the "Agreement"), pursuant to which the Grantor assigned and granted to Assignor a security interest in and to all of the Grantor's right, title and interest in and to certain trademark, trademark applications, and trademark rights, as more specifically listed on Exhibit A attached hereto (the "Marks");

WHEREAS, in connection with a subsequent asset purchase transaction, a Trademark Assignment, dated as of March 28, 2007, was recorded in the United States Patent and Trademark Office on March 29, 2007, at Reel 003511, Frame 0262, in which Grantor subsequently assigned in full its interest in the Marks to PULL'R HOLDING COMPANY, LLC, a Delaware limited liability company, ("PHC, LLC");

WHEREAS, pursuant to that certain Loan Sale Agreement, dated as of September 16, 2008 by and between Assignor and Assignee, Assignor sold, among other things, its lien and security interest in and to the Marks to Assignee; and

WHEREAS, the Assignor wishes to assign to Assignee all of Assignor's liens, claims and encumbrances respecting the Marks, without representation or warranty (collectively, the "Rights").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby assigns transfers and delivers its entire right, title and interest, including all liens, rights of action and damages for past infringement, in and to the Marks and the Rights, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, licensees or other legal representatives.


