## GENERAL ASSIGNMENT

This **General Assignment** ("this Assignment") is executed and delivered as of July 17, 2007 by Sultan Dental Products, Ltd., a New Jersey corporation with a principal place of business at 85 West Forest Avenue, Englewood, New Jersey 07631 ("Assignor"), in favor of Sultan Healthcare, Inc., a New Jersey corporation that is the sole shareholder of Assignor ("Assignee").

**WHEREAS**, in connection with a plan of liquidation and dissolution of Assignor, of even date herewith, adopted by Assignee, all of Assignor's right, title and interest in and to its assets (the "Assets") is to be assigned to Assignee;

**NOW, THEREFORE**, Assignor does hereby sell, assign, convey, transfer, and deliver to Assignee and its legal representatives, successors and assigns, to have and to hold forever, all right, title and interest in and to the Assets, including, without limitation, all accounts receivable, prepaid expenses, inventory, equipment, contracts and contract rights, patents, trademarks, technical and business information, books and records, leasehold improvements, the name "Sultan Dental Products," customer lists, choses in action, and goodwill and going concern value.

This Assignment shall be binding upon Assignor and its successors and assigns and shall inure to the benefit of Assignee and its legal representatives, successors and assigns. Assignor does hereby irrevocably constitute and appoint Assignee and its legal representatives, successors and assigns, its true and lawful attorney, with full power of substitution, in its name or that of Assignee, for the benefit of Assignee and its legal representatives, successors and assigns:

- (a) To claim, demand, collect, and receive, at any time and from time to time, and deliver to Assignee any and all assets, properties and other tangible and intangible rights sold, assigned, conveyed, transferred, and delivered pursuant to this Assignment;
- (b) To institute and prosecute all proceedings that Assignee may deem proper in order to collect, assert or enforce any claim, right, or title of any kind in or to the Assets and to do all such acts and things in relation thereto as Assignee shall deem advisable; and
- (c) To take all action that Assignee may deem proper in order to provide for Assignee the benefits of any claims, contracts, permits, or licenses where any required consent of another party to the assignment thereof to Assignee shall not have been obtained.

Assignor acknowledges that the foregoing powers are coupled with an interest and are and shall not be revocable in any manner or for any reason.

This Assignment shall be governed by, and construed in accordance with, the laws of the State of New Jersey.
