## ASSIGNMENT AND AGREEMENT

THIS ASSIGNMENT AND AGREEMENT (the "Assignment") dated as of this 29th day of September, 2008, is made by M-I L.L.C. ("M-I"), formerly doing business as M-I Drilling Fluids Company.

WHEREAS, M-I was assigned the ownership, rights, and good will associated with the trademarks WYOBOND (Reg. No. 0,922,087) and ULTRASEAL (Reg. No. 1,322,805) (collectively, the "Marks") on January 13, 1987 by Halliburton Company, then the owner of Federal Ore & Chemicals, Inc.;

WHEREAS, AMCOL International Corporation ("AMCOL"), formerly doing business as American Colloid Company, was subsequently assigned the ownership, rights, and goodwill associated with the trademarks WYOBOND (Reg. No. 0,922,087) and ULTRASEAL (Reg. No. 1,322,805) (collectively, the "Marks") on October 30, 1987 by Federal Ore & Chemicals, Inc.;

WHEREAS, AMCOL has continuously used the marks and maintained the registrations thereof since acquiring the marks;

WHEREAS, AMCOL desires to clarify and remedy the inconsistencies in the present chain of title as set forth in the Trademark Assignment Abstract of Title in the U.S. Patent and Trademark records and database;

NOW, THEREFORE, in consideration of the Recitals and of the covenants, conditions and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it hereby is agreed that :

1. M-I hereby assigns whatever ownership, rights and good will associated with the Marks:

WYOBOND (Reg. No. 0,922,087) and ULTRASEAL (Reg. No. 1,322,805)

that M-I or its predecessors may have (if any), to AMCOL.

2. M-I makes no admissions, representations or warranties with respect to the Marks that are not set forth in this Assignment.

3. AMCOL agrees to indemnify and hold harmless M-I for any and all costs and/or claims that may be made against M-I as a result of AMCOL's use of the Marks prior to the date of this Assignment.
