CERTIFICATE OF MERGER

of

NAVTEC, INC.
(a Connecticut corporation)

with and into

LEWMAR, INC.
(a Connecticut corporation)

Lewmar, Inc., a Connecticut corporation, hereby certifies that:

FIRST: That the names of the constituent corporations are Lewmar, Inc., a Connecticut corporation (hereinafter "Lewmar"), and Navtec, Inc., a Connecticut corporation (hereinafter "Navtec"), and that the surviving corporation is Lewmar.

SECOND: A Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of Navtec and Lewmar in accordance with the provisions of section 33-817 of the Connecticut Business Corporations Act. The Plan as so approved and adopted is on file at the principal office of Lewmar, which is located at 351 New Whitfield Street, Guilford, Connecticut, 06437.

THIRD: That the effective time of the merger shall be August 14, 2007, if this Certificate is filed with the Secretary of the State prior to such time or upon the filing of this Certificate with the Secretary of the State if it is filed after such time.

FOURTH: The Certificate of Incorporation of Lewmar, Inc., a Connecticut corporation, as now in force and effect, shall continue to be the Certificate of Incorporation of the surviving corporation until such time as it may be amended and changed pursuant to the provisions of the Connecticut Business Corporations Act.

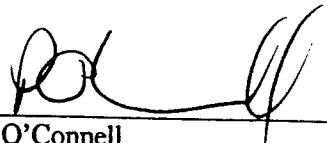
FIFTH: The Plan of Merger has been approved by the sole shareholder of Navtec, and such shareholders so approved the Plan by unanimous written consent. Pursuant to section 33-817(7) of the Connecticut Business Corporations Act, the Plan of Merger does not require the approval of the sole shareholder of Lewmar.

SIXTH: A copy of the aforesaid Plan of Merger will be furnished by the surviving corporation, on request, and without cost, to any stockholder of each of the constituent corporations.
