WHEREAS, CCC previously adopted and used the trademark AJAX TAVERN in connection with restaurant services (hereinafter, the "Mark");


WHEREAS, CCC is the owner of United States Trademark Registration No. 2,628,176 for the Mark (hereinafter, the "Registration"); and
