**TRADEMARK RELEASE**

**THIS TRADEMARK RELEASE** is made as of September 30, 2008, by General Electric Capital Corporation, as agent (in such capacity, "**Grantee**").

W I T N E S S E T H:

**WHEREAS**, Grantee and Norwesco, Inc., a Minnesota corporation ("**Grantor**"), are parties to that certain Trademark Security Agreement dated as of March 28, 2008 (the "**Security Agreement**"; capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

**WHEREAS**, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on April 2, 2008 at Reel 003751, Frame 0197; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Grantee.

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby terminates the Security Agreement and terminates, cancels and releases its security interest in all of Grantor's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action existing by reason of infringement thereof (the "**Trademark Collateral**").

2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any right, title and interest Grantee may have in and to the Trademark Collateral.

3. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Trademark Release.
