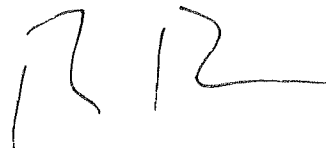
AFFIDAVIT

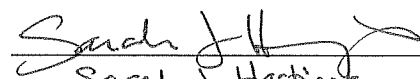

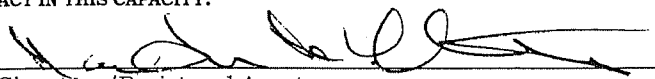
