TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Trademark Assignment") is effective as of August 4, 2008 (the "Effective Date"), and is by and between **Kraft Foods Global Brands LLC**, a Delaware limited liability company with a place of business at Three Lakes Drive, Northfield, Illinois 60093 ("KFGB"), and **Kraft Foods Global, Inc.**, a Delaware corporation with a place of business at Three Lakes Drive, Northfield, Illinois 60093 ("Assignee"). Each of KFGB and Assignee is a "Party" and collectively are the "Parties."

WHEREAS, Kraft Foods Inc., a Virginia corporation ("Parent"), Cable Holdco, Inc., a Delaware corporation, Ralcorp Holdings, Inc., a Missouri corporation and Ralcorp Mailman LLC, a Delaware limited liability company, are parties to an RMT Transaction Agreement (the "RMT Agreement"), dated as of November 15, 2007.

WHEREAS, the parties to the RMT Agreement intend that none of the transactions set forth in Article 2 of the RMT Agreement shall become effective unless all of such transactions become effective.

WHEREAS, in accordance with the RMT Agreement and this Trademark Assignment, KFGB has agreed to distribute all of its right, title and interest in, to, and under certain intellectual property relating to the Business (as defined below), including the Assigned Marks (as defined below) to Assignee;

NOW, THEREFORE, pursuant to KFGB's resolution dated July 22, 2008, authorizing the distribution of all right, title and interest in, to, and under the Assigned Marks to Assignee, the Parties hereby agree as follows:

I. DEFINITIONS

- 1.1 "Assigned Marks" shall mean the KFGB Trademarks.
- 1.2 "Business" shall have the meaning set forth in the RMT Agreement.

1.3 "Closing Date" shall have the meaning set forth in the RMT Agreement.

1.4 "Exclusively in connection with the Business" shall mean virtually exclusive use by KFG or its subsidiaries or its affiliates (including KFGB) in connection with the Business. Any use both in connection with and outside the scope of the Business shall not be deemed to have been used "Exclusively in connection with the Business" unless such use outside the Business is and/or was merely incidental, *de minimus*, negligible, immaterial, or insignificant.

1.5 "KFGB Trademarks" shall mean all right, title and interest in all U.S. or foreign (except for South Korea) trademarks, service marks, trade dress, trade names, symbols, characters, emblems, insignia, slogans, common law trademarks, product names, logos, label designs, product packaging, and other indicia of origin, all U.S., foreign, community, protocol, international, and other applications to register and registrations therefor, all renewals and extensions of any of the foregoing, the goodwill associated with any and all of the foregoing, and any and all remedies for and against past, present, and future infringement thereof, any damages relating thereto, and rights to protection of interests therein under all applicable laws, owned by KFGB or any of its subsidiaries, which, as of or prior to the Closing Date, are or were used Exclusively in connection with the Business (excluding only South Korean trademark registrations and any other South Korean trademark rights licensed to or used by Assignee's South Korean joint venture), have been held for use Exclusively in connection with the Business (excluding only South Korean trademark registrations and any other South Korean trademark rights licensed to or used by Assignee's South Korean joint venture), or were being developed for use Exclusively in connection with the Business (excluding only South Korean trademark registrations and any other South Korean trademark rights licensed to or used by Assignee's South Korean joint venture), including but not limited to those listed on Exhibits A and B hereto,

subject to any additions, deletions, or corrections pursuant to Section 4.2. KFGB acknowledges and agrees that "KFGB Trademarks" includes any and all right, title and interest it and/or its subsidiaries may have in, to, or under the Primary Marks, and all goodwill associated therewith, regardless of whether such marks were used Exclusively in connection with the Business.

1.6 "Primary Marks" are those trademarks listed on Exhibit C of this Agreement.

1.7 Capitalized terms used herein and not otherwise defined herein have the meanings given to such terms in the RMT Agreement.

II. ASSIGNMENT

2.1 KFGB hereby irrevocably assigns, transfers and conveys to Assignee all of its worldwide right, title and interest it now has or ever has had in, to and under each of the Assigned Marks in all jurisdictions where KFGB has rights, together with all benefits of the registrations and applications for registration therefor (to the extent they exist) and all right, title and interest in, to and under any renewals that may be granted, together with the goodwill of the business symbolized thereby. The right, title, and interest is to be held and enjoyed by Assignee as fully and exclusively as it would have been held and enjoyed by KFGB (or its subsidiaries) had this assignment not been made.

2.2 KFGB hereby irrevocably assigns, transfers, and conveys to Assignee, and Assignee shall have all benefits, privileges, causes of actions, claims and remedies arising out of or relating to the Assigned Marks, the exploitation thereof, and the use and ownership of any of the Assigned Marks, including but not limited to: (a) the exclusive right to apply for, own, and maintain all applications, registrations or renewals for the Assigned Marks; (b) any and all remedies against and for past, present or future infringements of the Assigned Marks or other violations of any rights in the Assigned Marks; (c) any and all rights to protection of interests in the Assigned Marks under all applicable laws; and (d) any and all rights to enforce, settle any

disputes, and retain all proceeds from any such actions. In the event Assignee subsequently elects to enforce any of its rights in, to, or under any of the Assigned Marks, KFGB for a period of five (5) years after the Closing Date shall (a) provide reasonable cooperation and assistance to Assignee with any and all such efforts; and (b) may be named as a plaintiff in any such action where applicable law requires KFGB's involvement as a party or where Assignee may not legally proceed or where Assignee's rights or damages may be materially limited absent KFGB being named a plaintiff. In the event that, in accordance with this Section 2.2, KFGB is required to provide cooperation or assistance or is named as a party to an action, Assignee shall reimburse KFGB for any and all reasonable, out of pocket expenses, including attorney's fees, that it may incur in connection with any such efforts or involvement. The Parties agree and acknowledge that the "reasonable cooperation and assistance" of KFGB shall not require KFGB or its attorneys or legal assistants to provide any strategic or legal assistance or advice.

2.3 Nothing contained in this Trademark Assignment shall give Assignee any rights in or to any mark, trade dress, or domain name not specifically conveyed under this Trademark Assignment, including any South Korean trademark registrations, South Korean trademark rights, or domain names that include a South Korean cctld used by or licensed to Assignee's South Korean joint venture.

III. ADDITIONAL DOCUMENTS

3.1 This Trademark Assignment shall automatically be binding on the Parties as of the Closing Date.

3.2 KFGB shall execute, verify, and acknowledge such documents or information reasonably necessary to: (i) transfer the Assigned Marks to Assignee and/or to record or otherwise make of record, or memorialize, the assignments of any Assigned Marks; (ii) confirm and/or vest Assignee's right, title and interest in, to and under the Assigned Marks; and/or (iii)

make of record with any government agencies, authorities, courts, or tribunals, the fact that Assignee owns all right, title, and interest in, to, and under the Assigned Marks and/or that KFGB and/or its subsidiaries and/or affiliates had, but no longer have, any right, title, or interest in, to, or under any of the Assigned Marks. KFGB shall execute all necessary instruments of assignment, transfer, or recordation for any of the Assigned Marks.

3.3 To the extent that a Trademark Office in any jurisdiction in which KFGB Trademarks are registered or in which any applications herein assigned are pending refuses to accept this Trademark Assignment as proof of the assignment of the marks and rights identified herein, or requests the execution, filing, or recordation of any other documents, KFGB shall execute any such requested or necessary confirmatory documents or assignments acknowledging that it transferred all of its rights, titles, and interest in, to, and under the KFGB Trademarks, and all goodwill associated therewith, to Assignee. KFGB agrees to execute any necessary confirmatory assignments within thirty (30) days of a request by Assignee.

IV. MISCELLANEOUS

4.1 If the terms and definitions of this Trademark Assignment conflict with the terms and definitions of the RMT Agreement or of any other agreements executed pursuant to the RMT Agreement, then the terms of this Trademark Assignment shall control.

4.2 KFGB and Assignee each acknowledge that it may be necessary to modify Exhibits A and B hereto in order to complete, or correct such Exhibits. In addition, KFGB and Assignee each acknowledge that it may be necessary to modify Exhibits A and B in order to make such Exhibits consistent with the Parties' understanding and intention that all the rights, title, and interest in, to, and under those trademarks used by KFGB and its subsidiaries Exclusively in connection with the Business as of the Closing Date, and all goodwill associated therewith, are to be assigned to Assignee. Should it be brought to the attention of either KFGB

or Assignee that a modification to one or more of the Exhibits hereto is required to complete or correct such Exhibits, the Party requesting the modification shall make a written request; provided, however, that any request by KFGB to delete a mark must be made within two (2) years of the Closing Date and shall be subject to the provisions of the last sentence of this Section 4.2. The Party receiving the request, within thirty (30) days after receiving the same, shall comply or advise the requesting Party as to its reasons for failing to comply with the request. Notices concerning modification requests shall be sent to the individuals and in the manner identified in Section 16.5 of the RMT Agreement. The Parties shall execute all documents necessary to effectuate the agreed-to modifications and this Trademark Assignment shall apply to any item added to Exhibits A and B, following any such modification. Notwithstanding the foregoing, (a) no mark shall be removed from Exhibits A or B on the basis that it is not used Exclusively in connection with the Business, so long as it is used primarily in connection with the Business; (b) no mark may be removed from Exhibits A or B that is a Primary Mark; and (c) in the event Assignee, its subsidiaries and/or affiliates was using any mark at the time a request for removal was received ("using" to include use in production), Assignee, its subsidiaries and/or affiliates as applicable shall have a commercially reasonable time to phase-out use of such mark, such that the cessation of such use shall have no more than an inconsequential cost to Assignee, its subsidiaries and/or affiliates as applicable, and KFGB shall not bring or cause to be brought any suit or action arising out of or in connection with Assignee's, its subsidiaries', and/or affiliates' (as applicable) continued use of such mark during such commercially reasonable time.

4.3 Each of the Parties hereto (a) consents to submit itself to the personal jurisdiction of any federal court located in the State of Delaware or the Delaware Chancery Court in the

event any dispute arises out of this Trademark Assignment or any of the transactions contemplated by this Trademark Assignment, (b) agrees that it will not attempt to deny or defeat such personal jurisdiction by motion or other request for leave from any such court and (c) expressly excluding any actions for declaratory judgment, patent infringement, copyright infringement, trademark infringement, unfair competition, dilution and related federal, state and common law causes of action, agrees that it will not bring any action arising out of this Trademark Assignment or any of the transactions contemplated by this Trademark Assignment in any court other than a federal court sitting in the State of Delaware or the Delaware Chancery Court. Each of the Parties hereto irrevocably consents to the service of any summons and complaint and any other process in any other action relating to the transactions contemplated by this Trademark Assignment, on behalf of itself or its property, by the personal delivery of copies of such process to such Party. Nothing in this Section 4.3 shall affect the right of any Party hereto to serve legal process in any other manner permitted by law.

4.4 This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of Delaware applicable to agreements made and to be performed entirely within such State, without regard to the conflicts of law principles of such State, except that matters relating to rights and obligations that are subject to national trademark rights will be construed under the applicable national trademark laws.

4.5 For purposes of this Trademark Assignment: (a) the words "include," "includes" and "including" shall be deemed to be followed by the words "without limitation"; (b) the word "or" is not exclusive; and (c) the words "herein," "hereof," "hereby," "hereto" and "hereunder" refer to this Trademark Assignment as a whole. Unless the context otherwise requires, references herein (i) to Sections mean the Sections of this Trademark Assignment and (ii) to an

agreement, instrument or other document shall mean such agreement, instrument or other document as amended, supplemented and modified from time to time to the extent permitted by the provisions thereof and by this Trademark Assignment. Headings of Sections are inserted for convenience of reference only and shall not be deemed a part of or to affect the meaning or interpretation of this Trademark Assignment. This Trademark Assignment shall be construed without regard to any presumption or rule requiring construction or interpretation against the Party drafting an instrument or causing any instrument to be drafted.


4.6 This Trademark Assignment constitutes the entire agreement between the Parties relating to the subject matter hereof and supersedes all prior agreements, understandings and representations concerning the subject matter, other than as may be set out in the RMT Agreement.

4.7 This Trademark Assignment may be amended or modified only by a written instrument signed by each Party.

4.8 This Trademark Assignment may be executed in one or more counterparts, all of which shall be considered one and the same agreement, and subject to the Closing under the RMT Agreement shall become effective when one or more such counterparts have been signed by each of the Parties and delivered to the other Party.


