# Purchase Agreement

between

Timesolv Corporation

(the "Buyer")

and

West Publishing Corporation,

West Service, Inc.

and

Elite Information Systems, Inc.,

(collectively Thomson – Elite)

(the "Sellers")

**BILL OF SALE**

This **BILL OF SALE** dated as of October 31, 2006, is made by and between West Publishing Corporation, West Services, Inc., for themselves and as successors in interest to Elite Information Systems, Inc. and Elite.com Inc. (collectively "Thomson Elite"), with a place of business at 5100 West Goldleaf Circle, Suite 100, Los Angeles, California 90056, and Timesolv Corporation, a Minnesota corporation, with a place of business at 4532 Alicia Drive, Inver Grove Heights, MN 55077 ("Buyer") and is delivered in connection with the transactions contemplated by that certain Agreement between Thomson Elite and Buyer dated as of October 18, 2006 (the "Purchase Agreement"). Capitalized terms not otherwise defined herein shall have the meanings given to them in the Purchase Agreement.

Thomson Elite, pursuant to the terms of the Purchase Agreement, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby bargain, sell, assign, transfer and convey to the Buyer and its successors and assigns all of the Thomson Elite's right, title and interest in and to the Purchased Assets. Delivery of this Bill of Sale constitutes receipt by the Buyer of the Purchased Assets, to have and to hold all such Purchased Assets for the Buyer and its successors and assigns for their own use and behalf forever.

Thomson Elite, for itself and its successors and assigns, further covenants and agrees with the Buyer and its successors and assigns that Thomson Elite will execute and deliver such other bills of sale, transfers, assignments and other instruments of conveyance and will do such other acts as reasonably requested by the Buyer further to vest in the Buyer such title to the Purchased Assets and to fulfill and discharge Thomson Elite's obligations of conveyance under the Purchase Agreement.

This Bill of Sale is executed and delivered pursuant to, and is subject to the terms of, the Purchase Agreement, and nothing contained herein is intended to alter, modify, expand or diminish the terms set forth in the Purchase Agreement, including the representations and warranties relating to the Purchased Assets.

This Bill of Sale may be executed by the parties hereto in separate counterparts and by facsimile, each of which when so executed and delivered shall be an original, but all such counterparts and facsimiles shall together constitute one and the same instrument.


